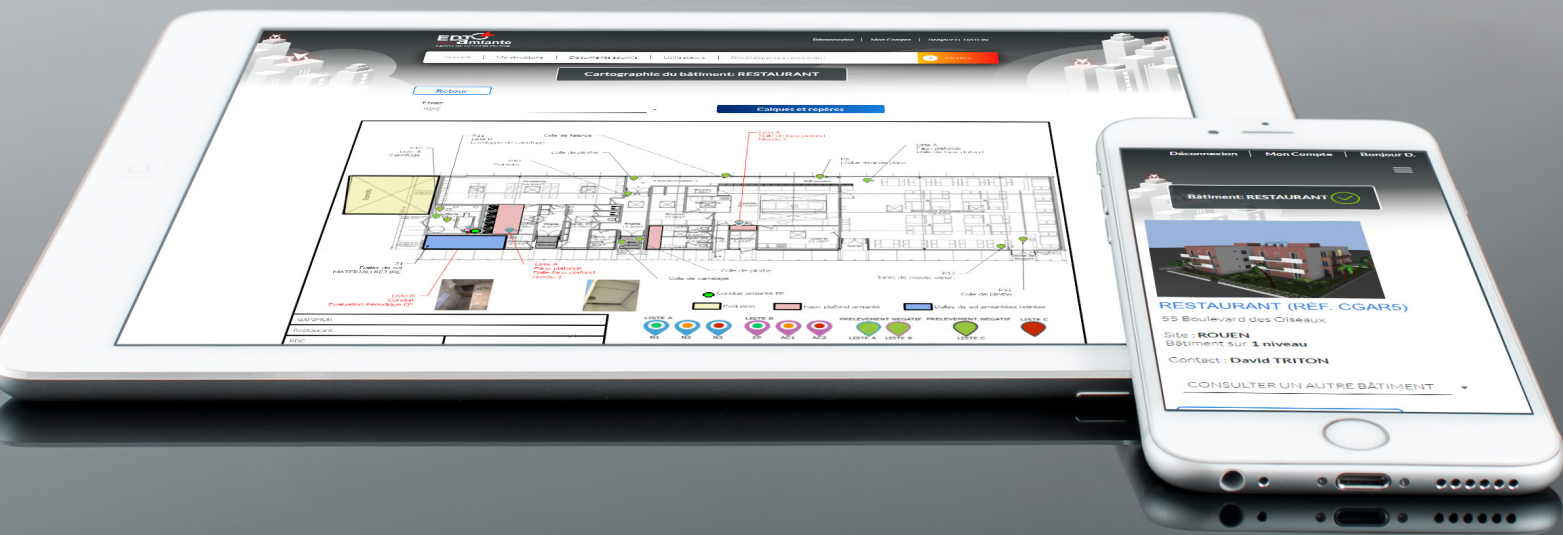

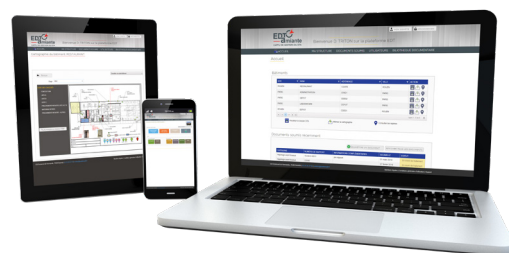

## WHAT IS AN ASBESTOS REGISTER ?

According to the WHS regulation, if any asbestos or asbestos-containing material (ACM) is identified in the workplace, a person with management or control of the workplace must ensure that an asbestos register is prepared and kept at the workplace. The asbestos register has to be maintained and up to date. The asbestos register contains any asbestos or ACM identified at the workplace, the date on which the asbestos or ACM was identified, the location, type and condition of the asbestos or ACM.
